
Release of Liability

PLEASE READ CAREFULLY. THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!

This Release and Waiver of Liability (the "Release") is executed on the date listed below ("Effective Date") by the participant identified below (the "Participant") in favor of Vitis House LLC, a North Carolina Limited Liability Company, and Doreen Colondres, personally, (collectively "Vitis House").

Understanding that

- Participant wants to engage in a tour facilitated by Vitis House;
- Participant understands that they are traveling, engaging in guided and unguided tours, staying at accommodations, and drinking and dining at locations facilitated by Vitis House (the "Tour");
- Participant is aware that the Tour may include navigating around certain cities, landscapes, streets, stairs, terrain, and locations in the course of the Tour;
- Participant understands that they may be exposed to environments, food, drinks, and people unknown and unfamiliar during the Tour; and
- Participant knows and understands that there are inherent risks in the Tour including travel, exposure to allergens, weather, physical activity, and other hazards inherent in the experience of of travel to a foreign countries and cities/towns.

Release and Waiver

Participant hereby releases, forever discharges, and holds harmless Vitis House and their successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Participant's Tour with, on behalf of, or which inure to the benefit of Vitis House.

Participant understands that this Release discharges Vitis House from any liability or claim that the Participant may have against Vitis House with respect to any allergic reaction, diet sensitivities, physical exertion, bodily injury, personal injury, illness, death, or property damage that may result from Participant's Tour with Vitis House, whether caused by the negligence of Vitis House or its officers, directors, employees, or agents or any other cause.

Medical Treatment

Participant does hereby release and forever discharge Vitis House from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Participant's Tour with Vitis House.

Assumption of the Risk

Participant understands that the Tour may include physical activity, ingestion, overnight accommodation(s), and the entering and visiting a foreign country/town. Participant knowingly accepts and assumes all risks associated with engaging in the Tour with Vitis House. Participant hereby expressly and specifically assumes the risk of injury or harm in the Tour and releases Vitis House from all liability for injury, illness, death, or property damage resulting from the Tour.

Photographic Release

Participant does hereby grant and convey unto Vitis House all right, title, and interest in any and all photographic images and video or audio recordings made by Vitis House during the Participant's Tour with Vitis House, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other

Participant expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of North Carolina, and that this Release shall be governed by and interpreted in accordance with the laws of the State of North Carolina.

Participant agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
